# APPLICATION GUIDELINES AND TERMS AND CONDITIONS

Waverley Artist Studios is based at the School of Arts, 138 Bondi Road, Bondi. Waverley Council facilitates five rentfree, non-residential artist studios in twelve month allotments. During the residency artists are provided with professional development opportunities to work with Waverley Council and the community. Applicants should read the guidelines carefully before completing the Waverley Artist Studios Application Form.

## INFORMATION FOR APPLICANTS ELIGIBILITY

Waverley's Artist in Residence
Program is open to visual artists
across all media. Applicants must have
an active ABN number, be Australian
citizens or permanent residents and
aged 18 years or older. Artists from
CALD or Aboriginal and Torres Strait
Islander backgrounds are encouraged
to apply. Waverley Council Councilor's,
and their families are ineligible to
apply to the studio program.

#### **SELECTION PROCESS**

A panel assesses all applications in order to create a preliminary shortlist with consideration given to:

- Artistic merit, as demonstrated in previous work including Exhibition credits
- Value of the residency to the applicant's professional development
- Potential of the artist's residency to engage with the community through Council's programs
- The overall quality of the application and support material

A panel made up of Waverley Council's visual arts staff and former studio artists will grade all applications against a set criteria based on the questions asked in the application. The Visual Art Team will prepare a report

to the Waverley Public Art Committee who will recommend a shortlist of artists for approval at Council meeting. If two or more preferred artists are scored of equal merit, preference will be given to artists who are current residents of Waverley LGA or display strong connection to the Waverley LGA.

#### **FUNDING**

Studio artists are expected to fund the costs of their own work. Waverley Council will provide studio artists with paid professional development opportunities where possible. Applicants are encouraged to apply for grants through organization's such as NAVA, createNSW and the Australia Council. Waverley Council provides letters of support to residents applying for grants to assist with the residency. Applicants with demonstrable or confirmed funding sources through grants or partnerships should be explicit to state this in their application.

#### **RESIDENCY DURATION**

The duration of the Studio term is twelve months February 2018 – January 2019. Previous residents can reapply to the program after a year out of the studios and will be graded against the same criteria in the marking pool of applications for the term in which are applying. Applications for back to back studio residencies will not be considered and previous residents.

#### **COLLABORATIVE RESIDENCY**

Each successful applicant will be allocated a studio based on the suitability of their practice to the space. Artists are expected to share the common areas (kitchen, bathroom, storage, garden). Participating artists are expected to respect the privacy and equipment of co-residents. Waverley Council encourages artists working

collaboratively to apply to the program.

## STUDIO PREPARATION, INSURANCES AND TRANSPORT

The resident artist is responsible for any preparation required to commence the residency and all furniture, equipment, materials and supplies they will require throughout the residency.

It is the responsibility of the resident artist to make their own accommodation arrangements and insurances including contents, medical and public liability. All studio artists are required to have a current NSW Working With Children's Check.

## NON-RESIDENTIAL UNFURNISHED STUDIOS

The studios provided under this program are non-residential, unfurnished spaces. Artists participating in the program cannot reside or live in the studios.

#### **PUBLICITY AND MEDIA**

The resident artist is required to participate in publicity activities related to the residency including planned 'Open Studio days'. Artists are required to provide digital images, give interviews or talks at forums and other events to promote the program.

#### **RESIDENCY AGREEMENT**

Prior to the commencement of the residency, artists and Waverley Council will enter into a contractual agreement based on the Arts Law of Australia Guidelines.

#### **APPLICATION**

Interested artists should complete the Application Form and submit with support material by the advertised closing date.
