

How to use 'Discover Waverley' for Draft WLEP 2022 changes

Waverley Council has an interactive online mapping tool, called 'Discover Waverley' to provide improved public access to a range of local Council information and services.

This information includes access to the existing Waverley Local Environmental Plan (WLEP) 2012 mapping and the proposed draft Waverley Local Environmental Plan (WLEP) 2022 mapping.

Whilst the WLEP 2012 currently has 14 different types of maps associated with it. The contents of only 3 maps are changing under the draft WLEP 2022.

The only maps with changes include:

- Active Street Frontages Map
- Land Reservation Acquisition Map
- Land Zoning Map

Follow these steps to see what status a property has under the current WLEP 2012 map, and what status a property has under the proposed WLEP 2022 draft maps.

1. Visit the 'Discover Waverley' website

2. Search for your property

Use the search bar on the top left-hand side of the screen.



3. Turn on the affected proposed layers and look at the WLEP 2022 maps

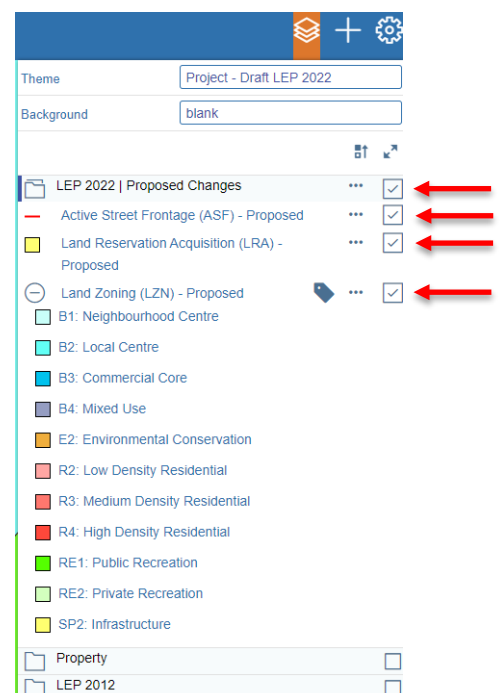
Adjust the right-hand-side bar to show "LEP 2022 | Proposed Changes" mapping and the 3 x boxes below it ticked.

If your property is proposed to be affected by an Active Street Frontage affectation, a red line will appear along one or more boundaries of the site on the map.

If your property is proposed to be affected by a Land Reservation Acquisition affectation, the part of the site proposed to be reserved will be shaded yellow.

The proposed Land Zoning will appear as a colour that corresponds to the legend shown on the right.

4. Compare the proposed against the existing WLEP 2012 maps

Turn off the “LEP 2022 | Proposed Changes” layer and turn on the “LEP 2012” layer in the right-hand-side bar.

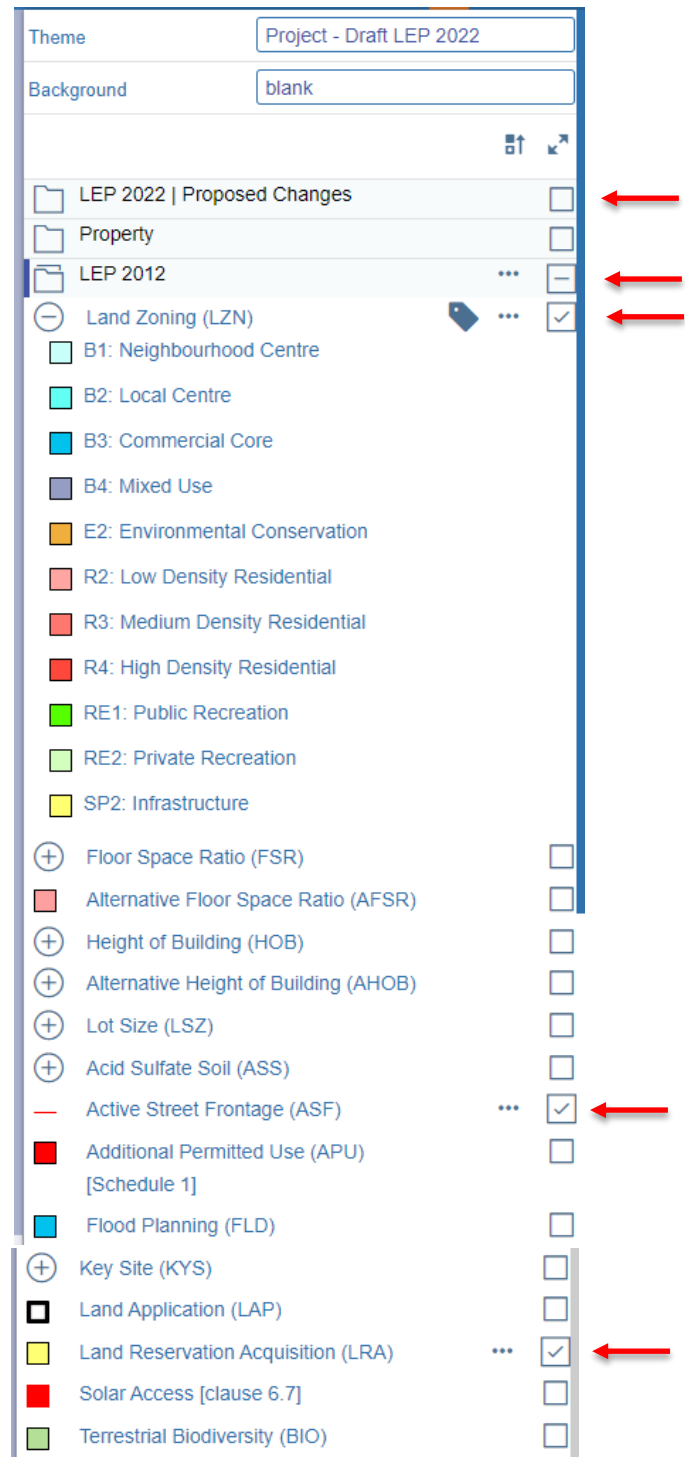
If your property is currently affected by an Active Street Frontage affectation, a red line will appear along one or more boundaries of the site on the map.

If your property is currently affected by a Land Reservation Acquisition affectation, the part of the site affected will be shaded yellow.

The existing Land Zoning will appear as a colour that corresponds to the legend shown on the right.

Other existing WLEP 2012 maps such as Floor Space Ratio and Height of Building are not being changed.
