SMOKE-FREE AREAS FACT SHEET

Waverley Council is committed to protecting the community from passive smoking by expanding smoke-free areas.

In the second half of 2015, Council officers engaged with businesses in Bondi Junction to measure their support of the establishment of a Smoke-Free area on a trial basis. The findings of this were presented to Waverley Councillors and at the December Council Meeting on December 15 2015, Councillors voted unanimously to commence a 6 month trial in Bondi Junction (from the hours of 7am-9pm) in early 2016.

This fact sheet outlines the scope of the trial and what it means to you.

Existing smoke-free areas in Waverley

Waverley Council already has a smoking ban in place on the sand of all of our beaches.

Breathe easy in Bondi Junction

Waverley Council is proud to be undertaking a smoke-free trial in the busy, open-air space of Oxford Street Mall, Spring Street and the adjoining parts of Newland Street and Bronte Road. The six month trial aims to promote a focus on a healthier way of life and improve the amenity of this area.

New signs will be installed and Council staff will be on sight to raise awareness about the new smoke-free area. The trial is scheduled to commence on 1 February 2016.

What are the benefits of smoke-free areas?


Smoke-free areas support the community in three main ways:

- Protect community from passive smoking
- Reduce uptake of smoking behaviour in children and young people by modelling non-smoking behaviour
- Provide a supportive environment for people who smoke who are trying to quit or have recently quit.

What is the smoke-free area in Bondi Junction?

The smoke-free area includes (refer to map below):

- Spring Street (from Bronte Road to Newland Street)
- Bronte Road (from Oxford Street to Ebley Street)
- Oxford Street Mall (including Rowe Street)
- Newland Street (Spring Street to Oxford Street)



How does Waverley Council select new locations to consider as smoke-free areas?

Waverley Council selects sites for consultation based on a number of criteria including location and total number of businesses, those with outdoor dining, adjoining buildings/properties, pedestrian traffic, as well as existing smoking controls.

What are the effects of passive smoking / second-hand smoke?

Exposure to second-hand smoke increases the risk of illness and death in non-smokers, from infancy through to adulthood. iCanQuit NSW says research has found second-hand smoke or passive smoking causes heart disease and lung cancer.
